VACUPAC stands for Virginia Credit Union Political Action Committee, the state-level, non-partisan political action committee of the Virginia Credit Union League and its affiliated credit unions. The sole purpose of VACUPAC is to raise money to help elect credit union friendly political candidates.

Political decisions made in Richmond and Washington can have a significant impact on the credit union industry and your future career. Contributing to VACUPAC gives you the opportunity to help elect lawmakers who support the interests of credit unions.

Federal political involvement is such a sensitive issue that the Federal Election Commission (FEC) long ago established a requirement that institutions "opt-in" to political action before being presented with actual information related to a Federal PAC. Signing the permission agreement doesn't obligate you to contribute or participate; it only allows us to send information about our activities related to the PAC and to solicit contributions.

Neither the League nor CUNA may send general solicitation mailings directly to your members, nor will we directly solicit your staff, volunteers or members. All information regarding making contributions to VACUPAC and/or CULAC will be communicated directly to the credit union CEO (or your Advocacy Ambassador) who can distribute the information accordingly.

HOW CAN WE RAISE MONEY FOR VACUPAC?

JOIN THE PIN CLUB!

No donation to VACUPAC is too small, but those who **JOIN THE PIN CLUB** receive special recognition. All PIN CLUB members receive a special lapel pin to wear proudly at credit union events and are recognized on the League's website and in our Annual Report.

We're often asked for guidance on an appropriate VACUPAC contribution for volunteers/staff at credit unions of various asset sizes. This guide was endorsed by credit union professionals/volunteer officials serving on the League's StateWide Advocacy Council (SWAC).

TWO EASY WAYS TO GIVE TO VACUPAC!

1. Payroll Deduction Programs

Payroll Deduction Programs offer the easiest way to give credit union employees the opportunity to support our advocacy efforts allowing them to contribute a smaller amount each pay period, and ultimately making a big difference. Please make sure you sign the Federal Election Permission Agreement before setting up payroll deduction.

- >In-house Payroll Deduction Program: Create a general ledger account to handle VACU-PAC contributions. Then your credit union wires or mails in checks to the League. We request that the contributions be sent in at least twice a year.
- >CUNA's Payroll Deduction Program: CUNA covers the wire fees for the transactions and provides a spreadsheet for easy transaction accounting. Visit www.cuna.org/cuts to get started and if you have questions, email cuts@cuna.org.
